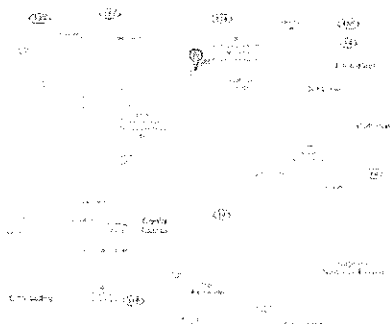

*The weather in Lake Hughes is usually different than in LA – especially as the seasons change. We advise that you check the weather before you leave, wear layers and bring warm clothes just in case.. Also, wear **CLOSED TOE shoes** – not sandals or flip flops.*

DIRECTIONS – FYI: GPS can take you up to 30 miles extra to get here.

From Los Angeles/San Fernando Valley

(For a canyon road experience):

Take 5N to LAKE HUGHES RD, EXIT 176B toward CASTAIC LAKE PARK. Turn RIGHT at exit ramp onto LAKE HUGHES RD for 23 miles & take it all the way to end. (This is a windy mountain road through Angeles National Forest). At the stop sign, Turn LEFT onto PINE CANYON ROAD/CR-N2. 18832 PINE CANYON RD is on the LEFT about a mile up.

(For less of a windy canyon road experience):

Take 5 N to the CA-126/NEWHALL RANCH RD. EXIT 172 and make RIGHT onto NEWHALL RANCH RD. (1.6 mi.). Turn LEFT onto COPPER HILL DR. (2.8 mi). Turn LEFT onto SAN FRANCISQUITO CANYON ROAD (5.9 mi). To stay on San Francisquito Canyon, turn a Slight Left (.and then take the 1st RIGHT (13.1 mi). Turn LEFT at ELIZABETH LAKE ROAD (5.4mi). which becomes PINE CANYON ROAD. (0.7mi) 18832 PINE CANYON RD is on the LEFT.

From Palmdale/Acton/CA-14N: (or also from the 5N if you want even less of a canyon drive)

(Take I-5 N to)CA-14 N via EXIT 162 toward PALMDALE/LANCASTER (34.9 mi).

Take the PALMDALE BLVD/CA-138 E exit, EXIT 35, toward PALMDALE (0.3 mi.) Turn LEFT onto W PALMDALE BLVD/CA-138 and follow for @ 1.0 mi. Stay STRAIGHT to go onto ELIZABETH LAKE RD/CR-N2, (19.7 mi). Stay straight as Elizabeth Lake Rd becomes PINE CANYON RD (0.7mi) 18832 PINE CANYON RD is on the LEFT.

From Lancaster/Quartz Hill:

Head WEST on W. AVENUE K, Turn LEFT onto 110TH ST W (0.7mi); which becomes JOHNSON RD (3.2 mi), becomes ELIZABETH LAKE RD (4.6 mi), becomes PINE CANYON RD (0.7 mi). 18832 PINE CANYON RD is on the LEFT.
